FIRMS IN THE NEWS!

- <u>Meredith Corp.</u> recently announced the start of DIGS, a new home and garden lifestyle channel that will be broadcast on YouTube. The <u>DIGS</u> channel features eight original series developed and produced by Meredith Video Studios that cover crafting, entertaining, gardening and home improvement.

FIRM SPOTLIGHT

DES MOINES INTERNATIONAL AIRPORT

The Des Moines International Airport (DSM) sits at the crossroads of the two major interstates of the continental U.S. and is the only Port of Entry airport in the state of Iowa. In November 2011 it became its own airport authority and is served by eight main air carriers [Southwest Airlines will begin service in 2012] which provide multiple daily flights for approximately 2 million passengers annually. Due to its location, DSM also has a strong presence of air cargo carriers. Its cargo apron is about 1.7 million square feet which is equivalent to enough concrete to pave 37 miles of sidewalks. The airport occupies 2,735 acres, has two 9,000 ft. runways and provides over 4,500 parking spaces.

DSM employs 75-85 people and they annually donate cash and food items to the Food Bank of Iowa. EWI executives representing the Des Moines International Airport firm are Don Smithey, Executive Director and Kevin Foley, Assistant Executive Director/General Manager with Gina Andre and Tara Ely as the EWI Representatives.
