Secretary: The August Board meeting was held on Monday, August 6. A motion to approve the July 9 Board of Directors minutes was approved.

Treasurer: Financials were provided through June 30. The Treasurer's report and listed payments were approved.

President: EWI updates were sent and corporate weekly updates were received. Attended the Purely Social event at Ikonox Studio. The Hospitality Committee has requested that each member send a "fun fact" about their firm. The Philanthropy Committee has requested notebooks for YESS be brought to the August meeting. Purely Social is hosting a "Super Greens" cooking class at Hy-Vee on Tuesday, August 7. Cost is \$10.

Vice President: EWI communications were received. Attended the Executive Night committee meeting. Assigned Sheryl Nichols as mentor to new member Carmella Heckard. Sent the budget information to the Budget Committee members and will meet August 8. Designed executives' invitation for the Executive Night. Designing the program for the Executive Night. Working on the chapter banner. Working on the LCAM sticker. Working on assigning members to club committees. LCAM attendees are Barbara, Christine, Sheryl, Linda, Nancy, Kim, and Tara. Dates to remember: 2012 LCAM is September 13-15, 2012 in Dallas, Texas. President's Caucus starts September 11, 2012; incoming vice president and president should attend. August 10, 2012 – President – Due to the Corporate Office: Form 6: Delegate/Alternate Credential Form AND Fees. The schedule for upcoming webinars was reviewed.
