### Partnership's Irwin is Deloitte CFO of the Year

Kirk Irwin, the **Greater Des Moines Partnership's** chief administrative officer, has been selected by the Business Record as the Deloitte CFO of the Year. The award will be presented to Irwin at the Business Record's Economic Forecast Luncheon on Jan. 25.

Irwin joined the Partnership, Central Iowa's economic and community development organization with 21 chambers of commerce and 5,000 business members, in September 2007 as chief financial officer and was later promoted to CAO. He oversees all financial aspects of the Partnership, which operates on an annual budget of almost \$9 million. His duties include budgeting and forecasting and audit and tax responsibilities. In addition, he handles other areas for the 43-employee organization such as human resources, risk management, IT, property management and more. He played a key role in the Partnership 2017's investor campaign Maximizing Momentum 2022, which broke records.

Before joining the Partnership, Irwin worked as the vice president and COO of Alliance Minerals North America and as the COO of the United Way of Central Iowa. He also held several executive positions with Proliant Inc. and the Lauridsen Group.

### **Need capital? Partnership offers advice**

The **Greater Des Moines Partnership** has two events coming related to raising capital. The Capital for Your Business seminar is from 8 a.m. to 1 p.m. Feb. 22 at the Partnership. This event will examine bank financing types and expectations, alternate loans, grants and buying on contract, with applications for restaurants, boutiques, medical practices, retailers, manufacturers and trade. The Raising Capital seminar, hosted by the Partnership's Square One DSM, will be from 8 a.m. to 3 p.m. March 8 at BrownWinick Law Firm. Registration for both events is available online.

### Incubator helps nonprofits find their synergies

An innovative co-working/incubator space for Greater Des Moines nonprofits that launched less than a year ago has attracted eight resident organizations and recently gained its first investor — **Delta Dental of Iowa**.

The Telligen Community Initiative Synergy Center, housed at the Iowa Center for Higher Education in Des Moines, is a program led by Telligen Community Initiative, a West Des Moines-based nonprofit foundation. The 5,000-square-foot office space on the University of Iowa's Des Moines campus on Fleur Drive brings together multiple health-related nonprofits to share office space, resources and ideas.

"We're at capacity right now, and just couldn't be more pleased with how this is evolving and the things we're able to do," said Matt McGarvey, executive director of TCI. "Delta Dental's support has really helped to kick-start what we hoped to accomplish from the capacity-building standpoint."

The eight participating nonprofits receive free rent, utilities, office cleaning, after-hours security, furniture, internet access, use of computers and printers, and access to campus conference rooms. The organizations can also participate in joint learning and training programs and are eligible for strategic consulting.

Jeff Russell, CEO of Delta Dental of Iowa, said his company's positive experience as an investor in the 4-year-old Global Insurance Accelerator in Des Moines aided in the decision by Delta Dental to invest \$30,000 in the Synergy Center.

"We ended up asking how could we do the same thing with the Synergy Center on the nonprofit side," Russell said. "How can we start to make this investment in financial sustainability and capacity for these nonprofits so they can continue to do the good work they're doing?"

Delta Dental's funding will focus on marketing and communications, but will also provide other support such as advising the organizations on board recruitment and building sustainable fundraising campaigns, Russell said. The



relationship will also extend to connecting Delta Dental's professional staff to provide expertise to the nonprofits, he said.

"We've got a lot of great, talented people here who can bring their expertise in a variety of ways, many of them in a health perspective," Russell said. One potential avenue of support is Delta Dental's corporate give-back program, in which it annually selects one organization for a monetary donation and volunteer project for its employees. Last year, for instance, employees helped assemble bicycles to donate to Variety — the Children's Charity.

"I think this is an opportunity to plug our folks in," he said. "I have a sense that there may be even more supply than demand. But that would be a good problem to have."

Russell said that Delta Dental will remain committed to the center, but the form of its support may vary from year to year. "The question is: What do they need? This year the focus was the communication plans; where else do they need infrastructure? Our goal is to get them to a place where they can be financially sustainable, where they can actually continue to do their work."

### **Crowell to retire from UnityPoint Health-Des Moines**

Eric Crowell, president and CEO of **UnityPoint Health-Des Moines**, today announced he will retire July 1. Over his 37-year career in health care, including 17 in his current position, Crowell has led organizations in Iowa, Illinois and nationally, and he has been an active volunteer in his community.

UnityPoint Health-Des Moines has undergone significant growth during Crowell's tenure, with key accomplishments including construction of Methodist West Hospital in West Des Moines, the merger of Partners in Health with Iowa Health Physicians to create UnityPoint Clinic, and the opening of new emergency departments at Iowa Lutheran Hospital, Iowa Methodist Medical Center, Blank Children's Hospital and Methodist West Hospital.

Before returning to Des Moines in 2001 to lead UnityPoint Health-Des Moines (formerly Iowa Health-Des Moines), Crowell was president and CEO of Trinity Health System in Moline, III. The Des Moines native graduated from East High School and has an undergraduate degree from Iowa State University and a Master of Hospital Administration degree from the University of Minnesota. "Eric is one of the rare leaders with the ability to establish a vision and inspire people to achieve more than they ever thought possible," said Kevin Vermeer, president and CEO of UnityPoint Health, which is UnityPoint Health-Des Moines' parent organization.

"It has been an honor to serve," Crowell said. "More than anyone, I wish to thank the employees of UnityPoint Health-Des Moines who inspire me every day. These dedicated professionals consistently deliver and create a compassionate environment for expert care. The success of UnityPoint Health-Des Moines is theirs, and I am proud to have stood by their side."

Crowell has served on numerous boards, including the boards of the **Greater Des Moines Partnership**, Des Moines University, Des Moines Performing Arts, **Grand View University** and the Alliance of Independent Academic Medical Centers. He received the distinguished Citation of Achievement Award from the College of Business at Iowa State University in 2011, is an East High School Distinguished Alumni, and was named a Distinguished Eagle Scout by the National Council of the Boy Scouts of America.

### TAI, IEDA, Partnership, W.D.M. pin hopes on lowans

The lowan Project, a new talent development initiative, lets people with lowa connections use a website to drop a pin on a map to show where they live now. The idea will be to encourage the former lowans to spread the word about the state, to get to know each other, and to consider coming back. The **Greater Des Moines Partnership** and the city of West Des Moines plan to hold dinners for the former lowans in Denver and Chicago this year. The project involves the Technology Association of Iowa, the Partnership, the Iowa Economic Development Authority and the city of West Des Moines. "TAI is excited to connect with tech-skilled Iowa expats and reacquaint them with the great tech companies, communities and job opportunities awaiting them back home," TAI President Brian Waller said in a statement. "The recruitment opportunity is that these folks already know the Iowa story; what they may not realize is that the tech industry is alive and thriving in Iowa." The map shows how many former Iowans have dropped their pin in a certain area. If you click on the spot, the app lists the people, their hometowns, and where they worked and studied in Iowa."



#### Water station project helps 54 lowa schools get healthier

It's now easier for students and staff at 54 lowa schools, including 18 Greater Des Moines schools, to feel the numerous health benefits of drinking optimally fluoridated water throughout the day. Through a partnership led by **Delta Dental of lowa Foundation**, Elkay water bottle filling stations were recently installed in these schools to update or replace existing water fountains. In addition, more than 40 of these schools applied for and received \$500 to design and implement an educational campaign to encourage students to drink more water. Studies show that more than 50 percent of children and teens are not properly hydrated during the school day, and often choose caffeinated beverages, sports drinks or energy drinks. The \$230,000 investment by Delta Dental of Iowa Foundation was supported by the Iowa Department of Public Health's Bureau of Nutrition and Health Promotion, the Iowa Public Health Association, the Iowa Department of Education and Balfrey & Johnston Inc. Signs in the schools will draw attention to the new water bottle filling stations, and "Rethink Your Drink" water bottles, toothbrushes, posters and bookmarks will be shared with students to support educational activities organized by the schools. Other Iowa schools interested in applying for a water bottle filling station can do so in early May.

### Wellmark pledges to re-enter individual health market in 2019

**Wellmark Blue Cross and Blue Shield of Iowa** announced Thursday that it plans to re-enter the individual health insurance market on the public exchange in Iowa next year, assuming there aren't any significant changes to the Affordable Care Act. In a statement, the Des Moines-based insurer said it "believes the individual market can be functional once again."

Wellmark had announced in April 2017 that it would exit lowa's individual health market in 2018, after absorbing \$90 million in individual market losses over a three-year period. The decision affected about 21,400 Wellmark policyholders at the time. The company said that it "will offer fully ACA-compliant products on the public exchange for 2019, assuming there aren't any significant changes to the Affordable Care Act. We will also explore offering additional options outside of the ACA for lowans, if state and federal rules allow us to do so.

"While there is no singular solution to stabilize the entire individual market in 2019, Wellmark will seek to offer options that provide more choice and affordability to lowans than they have today," Wellmark said in the release. "Wellmark believes the individual market can be functional once again. We pledge to continue working with state and federal officials, business partners, and other stakeholders to find a solution for all lowans in the individual and family insurance market."

### Partnership D.C. trip registration open

Registration for the **Greater Des Moines Partnership's** annual trip to Washington, D.C., is open. The trip runs May 9-11 and is expected to include lobbying sessions, tours, panel discussions, meetings with the congressional delegation and networking with nearly 200 Greater Des Moines leaders. Trip options include charter air service, ground transportation, baggage fees, two nights at the Washington Court Hotel on Capitol Hill, two luncheons, two breakfasts, one evening reception and one dinner. The full trip package is \$2,250 for investors and affiliate chamber members and \$2,450 for nonmembers. The price varies if you make your own flight and lodging arrangements. Registration is available online.

### FBL Financial fourth-quarter earnings see boost from corporate tax cut

**FBL Financial Group Inc.** reported net income attributable to FBL Financial Group for the fourth quarter of 2017 of \$108.5 million, or \$4.33 per common share, compared with \$26.9 million, or \$1.07 per common share, for the fourth quarter of 2016. Non-GAAP operating income, which excludes the effects of tax changes and gains and losses on investments and derivatives, totaled \$24.8 million for the fourth quarter, compared with \$25.6 million for the fourth quarter of 2016. Fourth quarter 2017 earnings per share reflect a one-time benefit from the Tax Cuts and Jobs Act of 2017 of \$85.8 million due to the remeasurement of net deferred tax liabilities using the reduced corporate tax rate. Full-year net income attributable to FBL was \$194.3 million, compared with \$107.2 million. Non-GAAP operating income for the year was \$4.32 per share, compared with \$4.25 for 2006. "Fourth quarter 2017 earnings results cap off a year in which FBL Financial Group achieved record highs in full year net income and non-GAAP operating income per share. At the same time we maintained a strong capital position and distributed \$81 million to our shareholders in 2017 via special and regular dividends," CEO James Brannen said in a statement.



### FBL Financial promotes Geadelmann to general counsel

FBL Financial Group Inc. has named Lori Geadelmann as general counsel, effective March 1. She succeeds David McNeill, who will retire from FBL after more than 28 years with the company. FBL CEO James Brannen said McNeill "leaves behind a distinguished career at FBL Financial Group. On behalf of everyone at FBL, I wish Dave well as he moves on to the next chapter of his life." Geadelmann, 52, joined FBL in 1993 and has held progressive leadership positions with the company over the last 25 years, most recently as vice president - assistant general counsel and corporate compliance officer. In her new role, she will be a member of FBL Financial Group's executive management team. Geadelmann serves on the life and health guaranty association boards in lowa, Colorado and Montana, chairing the lowa and Colorado boards of directors. She also serves as vice president of the lowa Insurance Institute and chairs the Life and Financial Services Committee for the Federation of lowa Insurers.

#### Convention center hotel board takes another step toward ownership

Sioux Falls, S.D.-based lender Great Western Bank plans to shoulder a \$40 million loan for the the Hilton Des Moines Downtown, the 330-room convention center hotel that is scheduled to open March 21, the day ownership passes to the nonprofit IEC Hotel Corp. The loan will cover a construction loan from **Bankers Trust Co**. Bankers Trust will act as trustee for IEC Hotel Corp. until an estimated \$101 million in total debt is repaid from a range of sources, including the bank loan, the capture of slightly more than \$19 million, excluding debt service, of a portion of hotel/motel tax revenue and sales taxes generated by a special district that includes the hotel, \$14 million in tax increment financing from the city of Des Moines, and a 3 percent facilities fees charged at the hotel. Polk County supervisors have authorized lending up to \$29 million, primarily by extending the terms of the payoff of the lowa Events Center. Gaming revenues from Prairie Meadows Racetrack and Casino are used to pay the events center debt. Based on projections from Hilton, the debts could be retired in 2037. On Monday, the IEC Hotel Corp. board gave board President Gerry Neugent authority to sign the more than 70 documents necessary to close on acquisition of the property.

#### Community Foundation tops \$76 million in 2017 donations

The **Community Foundation of Greater Des Moines** made \$42.5 million in grants last year, raising a record \$76.4 million in donations. The grants supported 2,100 charitable programs. The Community Foundation also provided administration for \$542 million in charitable funds. The addition of 175 new funds to Community Foundation brought the total managed by the Foundation to 1,808.

#### **Grand View Receives \$1.5 million gift**

**Grand View University** announced that it has received \$1.5 million to create The James E. Rasmussen and Duane M. Skow Chair in Pastoral Excellence at Grand View University. Thanks to a generous gift from Kurt and Lynette Rasmussen and Sandra Rasmussen, the endowment aims to preserve and strengthen Grand View's commitment to providing excellent pastoral leadership for current and future generations of students and enable Grand View's ministries and its partnership with Luther Memorial Church to become a model or a "center of excellence" for the larger Lutheran Church.

The Reverend Russell Lackey, Grand View's campus pastor, will serve as the first holder of the Rasmussen-Skow Chair. Rev. Lackey oversees Grand View's campus ministries and faith development for students, regardless of religious affiliation, and also serves as head pastor at Luther Memorial. Rev. Lackey's work also includes overseeing the NEXUS Institute, a grant-funded program aimed at encouraging high school students to pursue lives of ministry. The endowment will allow Rev. Lackey to focus his work on pastoral excellence while also determining ways in which his pastoral leadership at Grand View and Luther Memorial can have a positive impact within the larger Lutheran Church.

Kurt Rasmussen, a Des Moines native, 1988 alumnus of Grand View and board of trustees member, is president and CEO the Rasmussen Group. Lynette is corporate counsel for The Rasmussen Group. Sandra Rasmussen is a 1957 alumnus of Grand View. The endowment is named for Kurt and Lynette's late fathers, James E. Rasmussen, a 1957 alumnus of Grand View and Duane M. Skow. They were both longtime members of Luther Memorial and instrumental in establishing the joint pastor role at Grand View and Luther Memorial.

The Rasmussen Family has a long history of philanthropy at Grand View University, including support for the building of the GV Student Center's Jensen Bridge and Ibsen's Valhalla, The Rasmussen Center for Community Advancement Professions and support for the Johnson Wellness Center's Nursing Therapy Room.
