JANUARY 2017 BOARD MEETING RECAP

Vice President: General notes: put together the January Board packet and emailed to Tara Ely; working on revamping mentoring program.



For all members who joined EWI prior to May 2014, your renewal month is December. Your invoice will be sent to Member Zone for you to pay online.


